The Focus Awards Level 5 Diploma in Leadership for Health and Social Care and Children and Young People's Services (England) (RQF) is aimed at managers and advanced practitioners working in health and social care and children and young people's services. The qualification aims at developing the skills, knowledge and understanding of learners to the standards required to confirm competence in an occupational role to manage practice and lead others in adult health and social care provision or in children and young people's services. This qualification includes optional pathways in management, residential services and advanced practice.

ASSESSMENT METHODS

The Focus Awards Level 5 Diploma in Leadership for Health and Social Care and Children and Young People's Services (England) (RQF) is assessed internally. Each learner is required to create a portfolio of evidence which demonstrates achievement of all learning outcomes and assessment criteria associated with each unit.

The main assessment methods include:

- Direct observation of the learner's performance by their assessor (O)
- Outcomes from oral or written questioning (Q&A)
- Work products (WP)
- Personal statements and/or reflective accounts (RA)
- Outcomes from simulation, where permitted by the assessment strategy (S)
- Professional discussion (PD)
- Assignment, project/case studies (A)
- Authentic statements/witness testimony (WT)
- Expert witness testimony (EPW)
- Evidence of Recognition of Prior Learning (RPL)

PROGRESSION ROUTES

Learners wishing to progress from this qualification can:

- Undertake a degree in a related discipline
- Find potential job roles as managers and deputy managers in a wide range of adult care or children and young people's settings
